1. I am a graduate of Ottawa's Algonquin College Electronic Engineering. I have worked in the Telecommunications Field as an engineer for more than 20 yrs, I am an inventor with a patent pending printable battery technology in the USPTO and I had worked as a software developer for the Government of Alberta remotely until February 2022 when I fell ill and lost my job. I have been on Ontario Works since.

Application for Parenting Time

2. On April 06th 2022, I brought an application for Parental Time with my children because I had exhausted all sane and normal efforts to reach my children - the

respondent Cristina Casicas DeVante was maliciously blocking any and all access to speak and see my children - this was after I has lost my job as a software developer and was unable to give any money to her. My original application is attached to Appendix A to this my Affidavit.

Parenting Time Granted by DRO

3. On August 18th 2022 in a meeting with the DRO- I was granted parenting time with both my children - Monday and Friday for 30 minutes on the phone and to setup in person visits with Alex and Zander - details to be worked out later with the respondents lawyer - the DRO Agreement is attached as Appendix B to this my affidavit.
4. Per the DRO agreement I provided the respondents lawyer with the requested financial records by email and also informed him I am unable to meet the children in person because I do not have a car and reside in Ottawa (5 hours away). I was able to speak to Alex and Zander a few times by calling Alex's Mobile Phone; however, after the 3rd or 4th call, the respondent Cristina and Alex sat next to Zander (7yrs old at the time) and told him what to say to me, bullying him and telling him not to speak to me. I asked to speak to Alex and requested he stopped bullying Zander when it was his turn to speak with me. At that point I lost all communications with my children as the phone was no longer accessible and they never answer my calls again.

Blocked From speaking to Children

5. I sent several emails to the respondent Cristina and her lawyer but they all ignored my pleas to speak with my children. Find several email (over the course of months and years) request to fix the illegal blocking of my calls to my children to both the respondent Cristina and her lawyer (note the psychotic responses to my simple request) , attached as Appendix C to this my affidavit

Fraud and Forgery

6. In reviewing the documents for response for this motion I came across several acts on the respondents side of outright fraud and forgery of documents submitted to the court.

- a. There is a consent file filed solely by the respondent Cristina Casicas DeVante and her lawyer Leroy Crosse that has a forged version of my signature – the documents states I signed the 'consent' agreement in witness of Leyroy Cross her lawyer but I have never met Mr. Crosse ever and did not sign this document; hence this is forgery and fraud – they same for the other document "Seperation agreement" dated March 03 2014 in witness of someone I never met. Find these documents with my forged signature attached to Appendix D to this my affidavit.

Lost of income and place to live

7. Since losing my last job as a remote Software Developer for the Government of Alberta in February 2022 – I have been on government benefits namely Ontario Works, receiving less than \$700 a month despite applying for more than 300 jobs – in september 2025 I lost my Ontario Works social benefit – my only source of income. As of October 2025 I have no income and have also lost my lodging as I am unable to pay rent and I am officially homeless on the streets. Find attached Ontario works letters, documents and CRA assessments for the last 3 years (2024 is under assessment but I made less than \$10,000) as Appendix E to this my affidavit.
8. At this point I have not spoken to my children for more than 3+ years, Zander was only 7 years old and they loved speaking and spending time with me. It s shocking to see the lies, fraud and slander that is being used against me to prevent my children from speaking to their dad. Find attached one of many email I sent to the respondents lawyer requesting help to resolve tis communication blackage to my children – attached as Appendix F to this my Affidavit.
9. Based on my current financial situation of having no income and being homeless, I am requesting an order revoking the FRO agreement that was filed against me Case number: 1021836 – Currently the FRO takes all my GST, tax rebates, those little ampount of money can save my life being homeless on the street in winter.

10. I am also requesting enforcement of parenting time with my children based on the DRO findings of 18th August 2022.

Abuse of Court Process

11. I have read the affidavit of the respondent Cristina and it is clear to me that it was written by her lawyer, The amounts of fabrications, misinformation, framing and lies amounts to perjury on the honorable court. This is clearly abuse of the court process. A person can lie to another, can lie to the Judge and the Court but they cannot lie to God.

1. am a graduate of Ottawa's Algonquin College in Electronic Engineering. I have worked in the Telecommunications field for more than twenty years. I am also an inventor and currently have a patent in the USPTO for a printable battery technology.

2. In 2005, I met Cristina Devante then Cristina Casicas on a dating Website suggested by a friend. Cristina was living in Philippines and I was residing in Ottawa. After many months of communication, I visited Cristina in Philippines and met her family. After a month there we got married. I submitted an application to the Canadian Embassy for Cristina to emigrate to Canada.

3. In 2006, I was residing in Vancouver. I started a company called Ice tower Inc - I had developed a sophisticated security system. Cristina emigrated to Canada and we lived together. From this point on Cristina could not find work and stayed home. I not only took care of her but gave her money to send to her family as I know things were difficult there. There was NEVER any bad behaviour nor violence on my part as I was a loving husband. There was never any complaint to family or police. In 2007 Cristina was pregnant with Alex.

4. In 2008 my mother who lives in Ottawa got sick and we moved from Vancouver to Ottawa to help my mom. We stayed at my parents house and tried to assist her in bettering her health. Alex was born in 2008. I not only paid for everything but also feed Alex, change his diapers, played with him, put him to sleep, and took both of them for Drives and walks.

5. At this time I started research and development on my printable battery invention. We lived in Ottawa until 2011 when Cristina and I decided that we wanted to move and live in Philippines. At the time, I could not get funding for my invention so I decided to let her go there with Alex first and I will find a job to send money to build a house for us.

6. Cristina and Alex left for Philippines; Cristina found and bought a house with land. I could not find a job in my field, I ended up working in a Auto parts making factory as a factory worker making minimum wage - I worked night and day to send all the money to Cristina to pay for her house and Alex milk, food, clothes and diapers etc. I kept a little for my rent and food. Despite sending money continuously to her - the house is only in her name and I never cared about that fact. I just wanted her and Alex to have something.

7. In 2012 Cristina told me she wanted to come back because things were not safe in Philippines, there were floods and it was dangerous. I found an apartment for us in North York; Cristina and Alex came back and we lived together in the Apartment. Cristina told me not to work in the factory and pushed me to find a job in my field. With her motivating me, I found a job as an Engineer working for RBC at their Head-office downtown Toronto. Cristina was taking care of Alex while I worked and later took a College course in the medical field. We often went to the park, grocery shopping together, watched movies and did everything married couples do.

8. In 2013 we moved to an adjacent high-rise building on the ground floor. I had stopped working for RBC and decided to try to get funding for my battery. At that time, I found out there was things Cristina was doing while I was at work that literally broke my heart - I loved her and Alex but I knew I could not accept these things as it was too dark.

9. I approached the Superior Court in downtown Toronto and after looking at the available options I decided to separate from Cristina. I let her keep the apartment with everything inside- rental agreement in my name with a paid deposit. I also paid an additional two months for her. That was in May 2013.

10. I traveled to India with my business partner at the time to look at possible investment for my battery technology as him and I was not making any progress in Toronto. I was in India for 3 weeks then on advice from a business college I traveled to China to meet her ex-husband. I was in China for 6 months - during that time I created prototypes that were validated and had two offer for manufacturing. During my time in China - I sent money to Cristina several times at her request via Western Union.

11. In September or October of 2013 I returned from China and stayed with my Business Partner at the time -Arjun at his house in Toronto. I visited and saw Alex on many occasions. I did have some money at the time and decided to give Cristina \$2000/month per her asking. Cristina and Alex was still living in the same apartment under my rental agreement.

12. After returning to Canada I met two individuals who claimed to be business men that dissuaded me from doing business in China for my battery technology and said they can help me bring it to manufacturing quickly here in Canada. I had missed Alex a great deal and Cristina and I got back together after working things out. We resumed living together in the same Apartment with Alex.

13. I focused on my business with the three business partners and had plans for setting up a small test facility in California. Things did not work out as the partners turned out to be of ill intent and tried to steal my technology - A court case ensued which still is ongoing today. They are now facing criminal charges which I have brought against them.

14. Between 2014 and 2016 we lived together and I supported Cristina and Alex. Zander was born in 2015, I was there at his birth the same as with Alex. I took care Cristina, Alex and Zander; paid for the rent, food, utilities, delivered drinking water and all the bills. I was a good father that made sure these children were loved and cared for. When Alex was being bullied at school, I contacted the school principal, spoke to the teacher, called legal aid and the Catholic School Board - I tried every way to make the bullying stop - with my unceasing efforts it finally did. I also went back to College (Centennial College) to study International Business to assist in my battery technology. I travelled 2 hours to get to College and 2 hours to get back.

15. Between taking care of my family, bills, College and the court case I was drained physically and emotionally. I was also researching and developing a more powerful battery technology than my first. In June 2016, I got a call from a business colleague in China and I discussed my generation two battery technology - he was more than interested - He wanted to sponsor me to go there to have it validated by the Technical university so that we can bring it to manufacturing faster. I discussed this with Cristina and we decided that she would go to Philippines and live in their house there with Alex and Zander and I would go to China and try to get my new battery technology going. I would send money to support them while I am in China.

16. In September 2016 I took Cristina, Alex and Zander to the Pearson Airport and they went to Philippines. I waited for my Visa then went to China to work on my new technology. While I was in China, I visited Cristina, Alex and Zander in Philippines for a week. It was December 2016 and I took them to the Mall, where I bought Alex & Zander toys and clothes. I met with Cristina's family and have each of them money. I played with Zander and Alex - they had so much fun. I then returned to China. While I was there in China I sent Cristina my Bank Debit card so she would withdraw money in any ATM machine in Philippines - I had placed 7 or 8 thousand dollars in that account. I could not afford more because my business partner and I did not receive funding yet. I communicated with Alex and Zander via Skype during that time.

17. In 2017, Cristina, Alex and Zander returned to Canada and stayed with my family in Ottawa. Then later they moved to North York and Cristina found a basement Apartment through a friend. I returned from China in October/November of 2017 to file a court case for online defamation by criminals that tried to steal my printable battery technology. I stayed with my family in Ottawa. I spoke to Alex and Zander on the phone and Cristina asked me to come there to babysit Zander as he was still a baby and she needed to work. I stayed in the basement apartment and took care of Zander, feeding him and changing his diaper. I also took Zander and Alex to the park to play, took them to the store etc. I did this because I loved both Zander and Alex and they love me. I tried finding work in Toronto but failed.

18. In 2018 I found work in Ottawa for a startup company doing software design. I had been to a sleep clinic and been diagnosed with sleep apnea. I had to start using a CPAP machine to sleep. In 2019 I worked for a professional company as a software designer. During that time I have given Cristina \$14000 total in cash - not all at once. I used to drive from Ottawa to Toronto to spend weekends with Alex and Zander - I would sleep in Alex room. Cristina cooked for us. I took them to movies, the mall and restaurants often.

I bought Alex a X Box and Zander a Nintendo Switch. We played games together and spoke every day on the phone after I got home from work. It was a beautiful time. Alex and Zander were growing up healthy and happy. That made me happy. I made sure they had everything they needed and often fixed Alex laptop to be faster for his games to not lag as much. Every weekend I would visit, I brought toys, snacks and we played together and watched movies. I always slept at their basement apartment.

19. In 2020 I got sick and lost my job - I was in the Humber River hospital for 8 days. This was during the pandemic - I was living in Ottawa and I could not find work but I received CERB. I took all my all the money I got from CERB and some of my savings and gave it to Cristina. I always made sure Alex witnessed me giving the cash to her. I think it was 13 or 14 thousands in total - not all at once. I spoke to Alex and Zander everyday for hours. Zander and I made up characters that went on adventures - it was a way to play with each other on the phone. I kept trying to find a job but it was difficult despite 40 or so interviews.

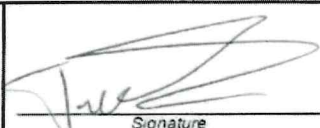
20. In October 2021 I found a job for the Alberta Government doing software design for the Digital Innovation Office - remotely. I moved to North York from Ottawa and lived in a rooming house. I gave money to Cristina but I could not afford the full \$2000 a month. She allowed me to take Zander and Alex out for two hours each weekend. I took them to the park, to light festivals, to movies etc.

21. In February 2022 I fell severely ill (not covid) and had to resign from my job. As soon as I lost my job I was not able to send any money to Cristina and she began blocking me from talking and seeing the Alex and Zander. The last time I spoke to and saw them was in February 2022. I tried contacting her via email and text message but I got what looked like psychotic long responses that made no sense. It did not have her grammar, style of writing nor did it follow the way she speaks/wrote - it included phrases and words that I knew she does not use. It seemed really strange - as though it was someone else responding for her. In any case, 3 months went by and I could not see or speak to Alex and Zander. I was forced to file a court case for parenting time because there was no other option available.

22. I have been a more than a good father to both Zander and Alex. I love them dearly and they love me. It pains me to see the court system being used as a tool to block me from spending time with my children. Both Zander and Alex can attest to these facts stated here in this affidavit.

23. I have read the affidavit of Cristina and it is clear to me that that was written by the lawyer - the amount of fabrications, misinformation, framing and lies amounts to perjury. This is clearly, abuse of the court process. One last thing, a person can lie to another, they can lie to the Judge and the Court but they cannot lie to God.

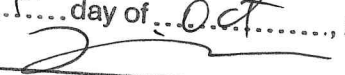

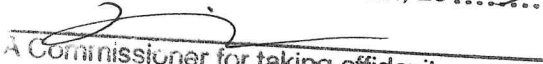
